The following amendment was read and voted on at an Executive Committee Meeting of the Nassau County Republican Committee held on December 22, 2025 at 164 Post Avenue, Westbury, New York.

BE IT RESOLVED by the Executive Committee of the Nassau County Republican Committee, that pursuant to Article IV, Section 2 (d) (iii), the following amendments are hereby made to the Rules and Regulations of the Nassau County Republican Committee:

1. Article IV, Section 2(b) is hereby amended by adding thereto:

(b) Executive District - (i) Immediately upon the election of the officers of the County Committee at the biennial organization meeting, the next order of business shall be the adoption of a resolution, setting forth the Election Districts of each Assembly District which shall constitute each of several Executive Districts. An Executive District may consist of Election Districts in more than one Assembly District. In constituting such Executive Districts, particular attention shall be paid to maintaining community unity and integrity as much as possible. **The Chairman of the County Committee is hereby authorized, during the interim between biennial organizational meetings, to reformulate the composition of one or more Executive Districts and/or merge two or more Executive Districts when, in the Chairman's judgment, such reformulation or merger is necessary or advisable to address vacancies, changes in Election Districts, changes in community unity and integrity, administrative efficiency, or to otherwise carry out the purposes of these Rules.** In addition to any other description which may apply under law (e.g., duly constituted subcommittees of the County Committee), Executive Districts shall constitute "party committees" within the meaning of New York State Election Law Section 14-100 (2), and shall have the powers and duties elsewhere described in these Rules.

2. Article IV Section 2(b) is hereby amended by adding a new section (vi) as follows:

**(vi) In the event of a vacancy in the position of Executive Committeeman, the Chairman of the County Committee is hereby authorized and empowered to appoint a qualified member of the County Committee to fill such vacancy. Any appointment made pursuant to this provision shall be effective immediately upon appointment and shall remain in effect until the next biennial organizational meeting of the County Committee.**

Motion to accept the amendment(s) was made by John B. Kiernan, Executive Committeeman of Willistons, seconded by John L. Maccarone, Executive Committeeman of Glen Cove, and carried unanimously.



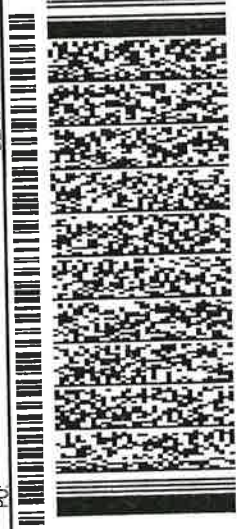
