### Temporary Amendment to the Official Rules of the Richmond County Republican Committee of New York

The members of the Executive Committee of the Richmond County Republican Committee of New York convened on Thursday, February 25, 2021 at 6:30pm via ZOOM. With a quorum being present, the following Temporary Amendment to the Official Rules of the Richmond County Republican Committee of New York was unanimously adopted, pursuant to Chapter 38 of the Laws of 2021:

Section 1: Pursuant to Chapter 38 of the Laws of 2021 of New York State and notwithstanding other provisions of the Official Rules of the Richmond County Republican Committee of New York (hereinafter referred to as "Rules"), Members of the Richmond County Republican Committee of New York (hereinafter referred to as "County Committee Members") that were elected in an odd year and whose terms are expiring in 2021 may remain in such office for an additional one-year term. Such County Committee Members shall be required to run in 2022 for a one-year term. In 2023 and thereafter, such County Committee Members shall run for two-year terms.

Section 2: This Temporary Amendment to the Rules shall be deemed repealed on December 31, 2023.




